THIS TRUST DEED is made the 29th day  
of February One thousand nine hundred and sixty  
BETWEEN CYRIL BEAUMONT of 75 Charing Cross Road  
M.B.2 in the County of London (hereinafter  
called "the Founder Patron") of the one part and CYRIL BEAUMONT  
WILLIAM COMPTON CARR BARBARA GEOGHEGAN CAROL JONES and NORA .  
SNELLING (hereinafter called "the Trustees" which expression  
shall include the survivors or survivor of them or other the  
Trustees or Trustee for the time being hereof) of the other  
part

WHEREAS: -

(1) The Cecchetti Society (hereinafter called "the Society")  
train students in the Art of the Ballet and at auditions  
held yearly a Board of Adjudicators consisting of one member  
of the Society and three members of the Royal School of Ballet  
(hereinafter referred to as "the Royal School") select from  
children trained by the Cecchetti Method students in the  
opinion of the said Board of Adjudicators suitable for train-  
ing at the Royal School and each Student so selected is awarded  
a scholarship for such amount and tenable under such conditions  
and for such period as the Committee of the Society from time  
to time determine

(2) Under the Rules of the Society the government thereof  
is vested in a Committee consisting of a Chairman and members

(3) The Founder Patron some years ago opened a fund for  
the benefit of students obtaining Scholarships and collected  
with the co-operation of Officers of the Society various  
sums of money amounting in the aggregate to One thousand six  
hundred and four pounds one shilling and no pence and these  
moneys have been paid to the Trustees who have consented to  
act as Trustees for the purpose of this Deed and the Founder  
Patron and the Officers of the Society are desirous of pro-  
viding for the future application of the said moneys and of  
all additions which may hereafter be made thereto in manner  
hereinafter appearing

NOW THIS DEED WITNESSETH that for effectuating the said  
desire and in consideration of the premises it is hereby agreed  
and declared as follows: -

1. The Trustees shall hold the said sum of One thousand six  
hundred and four pounds one shilling and no pence and all sums

of money hereafter given or bequeathed for the purposes of this Deed and all investments at any time representing the same or any part thereof (all of which are hereinafter included in the expression "the Trust Fund") and all income arising therefrom Upon Trust to pay and apply the same in accordance with the provisions and directions hereinafter contained

2. The Trustees shall out of the income or if and whenever such income shall be insufficient therefor then out of the capital of the Trust Fund:-

(A) Pay all costs and expenses of or incidental to the management of the Trust Fund and the income thereof or the execution of any of the trusts or powers of this Deed

(B) Establish and maintain in the place of the present Scholarships a Scholarship to be called "The Cyril Beaumont Scholarship" of such value as the Trustees shall in their absolute discretion from time to time think fit

3. The Cyril Beaumont Scholarship shall be awarded at such intervals and as the result of such examination and in such manner and shall be held and enjoyed for such period and upon and subject to such terms and considerations as shall from time to time be determined by regulations to be made by the Trustees and the Trustees may at any time revoke or alter any regulations made under this Clause and make new regulations in place thereof

4. The Trustees may at any time employ an Accountant Solicitor or other professional person to advise them on any point arising in connection with the trusts and powers of this Deed All fees of any person or persons employed under this Clause shall be paid by the Trustees out of the capital or income of the Trust Fund

5. The Trustees shall from time to time invest in their names any part of the capital or income of the Trust Fund in any of the following securities, viz: -

(a) In any of the investments specified in Sections 1 and 5 of the Trustee Act 1925

(b) In any investments in which Trustees may at any time hereafter be authorised by law to invest trust funds

(c) On mortgage of Leasehold property held for an unexpired term of not less than sixty years and not subject to a reservation of rent greater than one-fourth of the rack rent or

(d) Shall place the same on deposit in the names of the Trustees at any Bank

The Trustees may from time to time vary such investments for others of a like nature as often as they shall deem expedient and may sell or realise any such investments and obtain payment of any moneys so deposited as aforesaid

6. The Statutory Power of appointing new Trustees shall apply to this Deed and shall be exercisable by the Founder Patron during his life and after his death by the Chairman of the said Committee of the Society for the time being and upon any appointment of a new Trustee or new Trustees all money or investments representing the capital or income of the Trust Fund shall be paid or transferred to such new Trustee or Trustees jointly with the other Trustees or Trustee of this Deed for the time being or alone (as the case may be) and all acts deeds and things necessary for such purpose shall be done and executed and all costs of and incidental thereto shall be paid by the Trustees out of the capital or income of the Trust Fund
